Attended BP, Chevron, Shell, ExxonMobil, & TOTAL etc SIRE/CDI inspection as Owner's representative. Handling IMO II & III cargoes on fleet of chemical tankers mainly MEG, Naphtha, Methanol and Ethanol along with palm oil, lubes, bitumen and wax etc. Changing grades and tanking cleaning /preparing vessel /wall wash /nitrogen blankets was very challenging.
